NHS Dental Statistics, 2007-08

This release provides a summary of completed activity during the whole of 2007-08.

Key results:

Activity between 1 April 2007 and 31 March 2008:

- A total of 4,888,000 Units of Dental Activity were done during April 2007 to March 2008, representing 2,248,600 individual NHS dental claims for treatment.
- In 2007-08 the highest proportion of claims for treatment (52 per cent) were within Band 1 (routine examinations, scaling and diagnostic procedures).
- Band 2 treatments (fillings and extractions) was the band with the largest proportion of Units of Dental Activity (UDA) with 43 per cent of the total in the quarter.

Patients treated

• Provisional data shows that 1.60 million patients were recorded as having been treated in the 24 months before 31 March 2008, amounting to 54 per cent of the population. 65 per cent of the child (under 18 years) and 51 per cent of the adult population (18 years or over) were treated in the previous 24 months.

Workforce in the year ending 31 March 2008:

- There were 1,247 dentists with NHS activity recorded on FP17 forms.
- There were 4.2 dentists per 10,000 population.

Patient charges between 1 April 2007 and 31 March 2008:

• 41 per cent of all claims for treatment were for paying adults, the total patient charge for which amounted to £26.7 million.

Activity: Total claims for treatment

Activity data presented here is the total activity done for 2006-07 and 2007-08.

Chart 1: Number of claims for treatment by treatment band




Chart 1 shows the total number of claims for treatment for Wales during 2006-07 and 2007-08 by treatment band. In total in 2007-08 there were 2,248,600 claims for treatment, an increase of 9 per cent over 2006-07. In both years most individual claims for treatment were in Band 1 (routine examinations, scaling and diagnostic procedures). All bands showed an increase between the two years. See table A1 for more detail.

Chart 2: Claims for treatment by treatment band




Chart 2 shows that during both 2006-07 and 2007-08 the highest proportion of claims were within Band 1 (53 and 52 per cent respectively). Band 2 claims accounted for 32 per cent of all claims in both years, Band 3 for 4 per cent in 2006-07 and 5 per cent in 2007-08, urgent claims for 8 per cent in both years and free treatments for 3 per cent in both years. Activity: Units of Dental Activity

Units of Dental Activity (UDA) is the technical term used in the NHS Dental Contract regulations to describe weighted claims for treatment. They refer to the whole claim, not just individual items. The table below shows the weighting for each of the treatment category bands and is used to calculate the treatment claims by band figures. These figures reflect the completed picture for the whole year.

Chart 3: Total Units of Dental Activity




Chart 3 shows that a total of 4,888,000 UDAs (rounded to the nearest 100) were done during 2007-08, an increase of 12 per cent over 2006-07. See tables A3 and A4 for LHB counts and UDAs by band.

Chart 4: Total Units of dental Activity by treatment band




Chart 4 shows that for both 2006-07 and 2007-08, Band 2 treatments was the band with the largest proportion of UDAs (45 and 43 per cent respectively). Band 1 accounted for 25 per cent in 2006-07 and 24 per cent in 2007-08. Band 3 treatments accounted for 25 per cent in 2006-07 and 27 per cent in 2007-08. Urgent treatments accounted for 4 per cent in 2006-07 and 5 per cent in 2007-08. Other treatments types accounted for 1 per cent in both years.

Patients treated

The number of patients treated is a count of the number of distinct patient identities which have been processed during the last 24 months. Primary Care Trusts in England have recently raised some issues which suggest that the way in which patients are allocated to PCTs across the various quarters needs to be reviewed. To ensure that patients within Wales are also allocated correctly, information on patients treated at LHB level has not been published in this release. The Dental Services Division (DSD) of the BSA has confirmed that this issue could only have a minimal impact on the national figures. They have therefore been labelled as provisional pending the review. Further information on this review will be available in due course.

Provisional data shows that 1.60 million patients were recorded as having been treated in the 24 months before 31 March 2008 amounting to 54 per cent (or strictly "per 100 LHB residents" as patients may not be treated in their resident LHB - see notes). 65 per cent of the child (under 18 years) and 51 per cent of the adult population (18 years or over) were treated in the previous 24 months. Counts for previous years are shown in table A5.




Chart 5: Percentage of adults treated in the previous 24 months (a)

Provisional data shows that 1.2 million adult patients (aged 18 years or over) were treated by dentists in dental contracts in the 24 months ending 31 March 2008, 51 per cent of the population. Chart 5 shows that this a decrease of two percentage points from the 53 per cent treated in the 24 months ending 31 March 2006.




Chart 6: Percentage of children treated in the previous 24 months (a)

Provisional data shows that 416,800 child patients (aged 0-17 years) were treated by dentists in dental contracts in the 24 months ending 31 March 2008, 65 per cent of the population. Chart 6 shows that this a similar percentage to those treated in the 24 months ending 31 March 2006.

Workforce

Further to a recent consultation exercise, the workforce figures presented in the release are based on a new definition. This consultation arose due to problems with the way in which dentists were counted in 2006-07, the first year of the new dental contract system. They now measure the number of dental performers who have any NHS activity recorded against them via FP17 claim forms at any time in the year that met the criteria for inclusion within the annual reconciliation process. The data also considers those who worked in 2006-07 and not in 2007-08, and vice versa. As a result of technical issues raised as part of the consultation exercise, it will be necessary to undertake further work to determine whether consistent figures can be produced for the contract system which was in place before 2006-07.



A total of 1,247 dentists who had NHS activity were recorded during the year ending 31 March 2008, an increase of 106 (9 per cent) over the previous year. This figure includes Vocational Dental Practitioners (trainees) recorded on the system; as at 31 March 2008 there were 60 centrally funded Vocational Dental Practitioners, the figure for 2007 was 59. There were 4.2 dentists per 10,000 population in the year ending 31 March 2008, an increase from 3.8 the previous year. See table A6 for LHB counts.

Table A6 also shows the number of NHS dentists by Dentist Type. A dentist has been categorised as either a 'Performer Only' dentist or a 'Providing Performer' dentist. Detailed definitions are included in the notes on page 10. In 2007-08, 472 (38 per cent) were Providing Performers, dentists who have a direct contractual relationship with the LHB. This was slightly fewer than in 2006-07. The other 775 (62 per cent) were Performers Only, a 16 per cent increase on 2006-07.


Chart 7 shows the number of dentists in Wales who had NHS activity recorded during 2007-08 by age and gender. In 2007-08 the numbers of male and female dentists aged under 35 were similar but over 35 there were more than twice as many male dentists as female dentists. In 2007-08 12 per cent of all dentists were 55 years old or over and 39 per cent were female.

Table A7 shows that although overall in Wales, during 2007-08, 12 per cent of dentists were aged 55 or over, in some LHBs the proportion was much higher; in Pembrokeshire for example more than 1 in 5 are aged 55 or over whereas only 5 per cent in Wrexham were in this age group. The proportion of dentists who were female was 39 per cent for Wales but varied from 21 per cent in Merthyr Tydfil to half in Wrexham.

Table A8 shows the number of dentists by contract type. A performer is assigned a contract type by looking at all the contracts a performer has activity recorded against and assigning a contract type based on all their contracts. This must be calculated at each level (Wales/Region/LHB) for which the data is to be presented. For example, a performer could have contracts with more than one LHB within the same Region. If one contract was GDS, and the other PDS, they would be GDS for the first LHB, PDS on the other, but mixed for the Region, and mixed for Wales.

46 per cent of dentists, in 2007-08, were working on Personal Dental Service (PDS) contracts compared with 47 per cent the previous year and 43 per cent were on General Dental Service (GDS) contracts compared with 45 per cent the previous year.

In 2006-07 60 dentists (5 per cent of all dentists in 2006-07) stopped performing NHS work. Of these 34 were male and 26 were female. Of the males who left 20 were aged under 35 (8 per cent of males aged under 35) and 7 were aged 55 or over (6 per cent of males aged 55 or over). Of the females who left 16 were aged under 35 (8 per cent of females aged under 35) and 2 were aged 55 or over (11 per cent of females aged 55 or over).

In 2007-08 166 dentists (13 per cent of all dentists in 2007-08) started performing NHS work. Of these 76 were male and 90 were female. Of the males who started 57 were aged under 35 (22 per cent of males aged under 35) and 12 were aged 35-44 or over (7 per cent of males aged 35-44). Of the females who started 69 were aged under 35 (28 per cent of females aged under 35) and 12 were aged 35-44 (10 per cent of females aged 35-44).

Patient charges

Patient charges are paid by adult patients who are eligible for charges. The level of the charge is determined by the treatment band. Some patients do not pay for their NHS treatment. The main groups of non charge paying patients are children or 18 year olds in full time education, pregnant women and nursing mothers, adults on low income or in receipt of certain benefits and patients treated in hospital (although treatments for the latter are not included in this release).

Overall in 2007-08 there were 921,600 adult claims for treatment which were chargeable, an increase of 4 per cent over 2006-07. The total patient charge for these patients amounted to £26.7 million, an increase of 18 per cent over 2006-07. There were 675,400 exempt treatments for adults and 585,000 exempt treatments for children an increase of 22 and 6 per cent respectively. More details for LHBs are shown in Tables A10 and A11.




Chart 9: Claims for treatment for chargeable adults as % of all claims for treatment

41 per cent of all claims for treatment were for paying adults in 2007-08 compared 44 percent in 2006-07. This proportion varied across LHBs according to the profile of the local patient population. Chart 8 shows that the lowest percentage of treatments that were for paying adults was recorded in Pembrokeshire and the highest in Powys.




Chart 10: Treatments by type of patient and treatment band

Band 1 claims for treatment accounted for 48 per cent of treatments for chargeable adults, 54 per cent of treatments for exempt adults and 62 per cent of treatments for children. Band 2 treatments for each patient type ranged from 28 to 36 per cent. 8 per cent of claims for treatment for children were in Band 3, higher than for the two other patient groups. Chargeable adults also had the highest proportion of urgent claims for treatment (11 per cent).

Key Quality information

Coverage

The release covers NHS dental treatment undertaken by 'high street dentists'. It does not cover private work carried out by dentists nor dentists working in the hospital or community dental service. The figures relate to activity during the period April 2007-March 2008, and are obtained from reports compiled by the Dental Services Division (DSD) of the NHS Business Services Authority for management purposes.

The data are drawn from reports compiled by the NHS Business Services Authority (BSA) using completed FP17 forms and information supplied to LHBs for local management purposes. The data covers General Dental Service (GDS) and Personal Dental Service (PDS). Dentists can work under several different GDS/PDS contracts. This makes it very difficult to separate out, hence the activity and patient charge data has not been split between contract types. The release does not cover Hospital and Community Dental Service or services provided privately. The activity and patient charge data exclude orthodontic work which has its own activity measure. The workforce and patients treated data includes those performers with orthodontic contracts.

Comparability

This is the second annual publication of completed end of year figures following the introduction of the new NHS dental contract on 1 April 2006. This release provides a summary of completed activity during the whole of 2007-08.

Further to a recent consultation exercise the workforce figures presented are based on a new definition and are not comparable with figures previously published (see below section on Workforce data).

Data in this release is not comparable with previous bulletins under the old contractual arrangements.

Stability

The new data, both activity and workforce, have been subject to instability because of the newness of the arrangements but is becoming more stable.

Notes

Claims for treatment Information on any NHS dental work completed by an NHS dentist is submitted to the NHS BSA for payment on an FP17 form, the majority of which are electronic submissions.

Figures presented here on claims for treatment done by month/quarter relate to:

- (a) an examination of a patient, an assessment of their oral health, and the planning of any treatment to be provided to that patient as a result of that examination and assessment; and
- (b) the provision of any planned treatment (including any treatment planned at a time other than the time of the initial examination) to that patient.

Treatments are split into treatment bands which are used to determine the charge paid by patients. These include:

- Band 1 routine examination, scaling and diagnostic procedures
- Band 2 fillings and extractions
- Band 3 treatment requiring laboratory work

Urgent - one of a specified set of possible treatments provided to a person in circumstances where:

(a) prompt care and treatment is provided because, in the opinion of the dental practitioner, that person's oral health is likely to deteriorate significantly, or the person is in severe pain by reason of his oral condition; and

(b) care and treatment is provided only to the extent that is necessary to prevent that significant deterioration or address that severe pain.

The Band is determined by the most complex treatment included in the claim. The patient charge for the urgent band is the same as that for Band 1.

Other work is categorised into the following non-chargeable bands: Arrest of bleeding, bridge repairs, denture repair, removal of sutures and prescription issues.

Patients treated

This is a count of the number of distinct patient identities which have been processed during the last 24 months. The methodology for matching patients is not always exact, and is based on patients being identified using surname, first initial, gender and date of birth. This measure is not directly comparable with patient registrations published under the old contract.

Each unique patient ID is counted against the dentist contract against which the most recent claim was recorded in the 24 month period, with the following exceptions: if the most recent claim is for urgent treatment, orthodontic treatment, free treatment or treatment on referral, the ID remains with the previous contract, if there is one within the 24 month period. If a claim for the previous contract occurred before the 24 month period the ID is allocated to the most recent contract. There are circumstances where this statistical indicator of the overall level of patient involvement with NHS primary dental care will not strictly correspond to the number of different individual patients. In particular, if two patients share the same surname, initial, sex and date of birth, then they may give rise to only one count in a two-year period, and that one count may alternate between the LHBs with whose dental contractors the patients attend. This is more likely to occur for common surnames. Conversely, if one patient appears twice, under two different IDs, then the count will be inflated. The obvious example of this is when a person changes name on marriage.

The records relate to the date on which a claim was processed, not the date of attendance at the dental surgery.

Children are defined as patients under 18 on the date of acceptance.

Primary Care Trusts in England have recently raised some issues which suggest that the way in which patients are allocated to PCTs across the various quarters needs to be reviewed. To ensure that patients within Wales are also allocated correctly, information on patients treated at LHB level has not been published in this release. The Dental Services Division (DSD) of the BSA has confirmed that this issue could only have a minimal impact on the national figures. Workforce definitions:

Provider - A person or body authorised to enter into a contract to provide dental services for a Primary Care Trust or Local Health Board.

Performer - A dentist named on a contract who will or might be carrying out the work agreed in the contract.

Providing Performer – A provider that holds a contract with a PCT/LHB and also performs NHS dentistry on the contract.

Performer Only - A dentist that performs NHS activity on a contract, but does not hold the contract with a PCT/LHB themselves.

Age – Age is calculated as the age of the performer at the mid point in the year (30 September). Performers are assigned to an age band based on the age that is calculated from the POL data. No ages are queried.

Contract Type –A performer is assigned a contract type by looking at all the contracts a Performer has activity recorded against and assigning a contract type based on all their contracts. This must be calculated at each level (Wales/Region/LHB) for which the data is to be presented. For example, a performer could have contracts with more than one LHB within the same Region. If one contract was GDS, and the other PDS, they would be GDS on the first LHB, PDS on the other, but mixed for the region, and mixed for Wales.

Dentist Type - This refers to the way dentists contract and perform their work. Local Health Boards (LHBs) hold contracts with *providers* to deliver an agreed level of dental service. A *provider* that subcontracts all the dental activity on a contract to *performers* and does not perform NHS dentistry on the contract themselves is classed as *provider only*. A *provider* may also act as a performer (*providing performer*) and deliver dental services themselves. Other dentists will be *performers only* and will deliver dental services but not hold a contract with the LHB themselves (i.e. they will be working for a provider only or 'provider & performer' dentist). As the workforce numbers presented in this report are of dentists performing NHS activity, provider only dentists are excluded from this analysis.

A performer is assigned a Dentist Type categorisation based on the contracts they have activity recorded against. This examines every individual contract to see if the Performer is also the Provider for a contract. For every record where the Performer is also the Provider on a contractor, it is categorised as a Performing Provider. For contracts where the Performer is not the Provider, these are categorised as Performer Only. These are then grouped by Performer and by the reporting level (Wales/Region/LHB) assigned a category based on all contracts at each level. If the Performer is a Provider on any contract within a level, they are categorised as a Providing Performer, otherwise they are categorised as a Performer Only dentist. This takes no account of whether the Performer is listed on other contracts that they are not a Performer on, as the figures in this report are a count of dentists with activity recorded against them via FP17 forms, and not of Providers. Dentist type can vary by Performer depending on the regional level the data is being presented.

Joiners and Leavers

A Leaver is defined as a performer that had activity recorded against them via FP17 forms in a year, but none the following year. They would be recorded as a leaver in the first year. This definition results in information on the number of leavers for a particular year not being available until the end of the following year's reconciliation period.

A Joiner is defined as a performer with activity recorded against them via FP17 forms in a year, but none in the previous year. They would be recorded as a starter in the latest year.

Both Leavers and Joiners are categorised at a national level but presented at more local levels (i.e. leavers at a LHB level only include those that do not work in any other LHBs nationally). Movements between LHBs are classed as transfers, not leavers or joiners, and would therefore not be included in this report.

Following the above definitions, and as data for the years of the new contractual arrangement only are included in the report, the time series of leavers and joiners for both years is incomplete as this stage.

Information on the numbers of leavers prior to 2006-07 are not available at this time as further work is needed to ensure that the measure can be consistently applied across contract systems.

Information on the number of joiners in 2006-07 is also not available at this time as this would needed to be compared to 2005-06, and at this stage it is not clear as to whether the data is comparable.

Patient charge

Patient charge revenue is calculated using the information processed from the FP17 forms processed. In general, a non-exempt (paying) patient will pay the charge appropriate to the treatment. However, there will be certain cases where an FP17 for a non-exempt adult would not attract the full patient charge or would attract no charge, which are:

- The FP17 was a continuation of treatment (no charge or charge reflects difference in band charges).
- The FP17 was for treatment on referral (patient charge is collected by referring dentist).
- The FP17 was for a treatment that qualifies for free/repair replacement (no charge to replace or fix an item within 12 months of original treatment).
- The FP17 was for a patient that did not complete treatment (patient charge deducted for band of treatment actually provided, but reported as band of treatment planned).

Patient charges cannot be collected from closed contracts (or contracts on which payments are not being made). The counts of FP17s processed for closed contracts are included however, so patient charges may appear lower than anticipated. Patient charge revenue does not include charges due for courses of treatment which began before 1 April 2006 but were completed in 2006-07. No account is taken in this data of refunds for patients who pay for their treatment and prove at a later date that they should not have paid charges, or penalties imposed on those who should have paid but did not.

Exemptions

Patients are exempt from NHS dental charges if at the time the treatment starts, they fall into one of the following categories:

- Aged under 18; Aged 18 in full-time education.
- Aged under 25 or 60+ (examination and report only).
- Pregnant, or have had a baby in the 12 months before treatment starts.
- An NHS in-patient and the treatment is carried out by the hospital dentist.
- An NHS Hospital Dental Service out-patient

(Hospital treatments are not included in this report so the last two categories above do not apply to these statistics.)

if they qualify for remission of charges on the following benefit eligibility grounds:

- Getting, or have a partner who gets Income Support, income-based Jobseeker's Allowance or Pension Credit Guarantee Credit
- Entitled to, or named on, a valid NHS tax credit exemption certificate
- Named on a valid NHS Low Income Scheme HC2 certificate.

If patients are named on a valid NHS Low Income Scheme HC3 certificate then they may be eligible for partial help with dental costs.
